## **Southlake Sister Cities Homestay Program Host Family Participation Policy**

In consideration of the acceptance of the Host and its family members (collective the “**Host Family**”) for a visiting guest or guests (the “**Guests**”) for Southlake Sister Cities Homestay Program (the “**Homestay**”), each member of the Host Family agrees as follows:

1. The Activities. The “**Activities**” include all activities pertaining to the Homestay, including, but not limited to, hosting of one or more Guests and providing lodging, food, and reasonable assistance to the Guests at the Host’s household.

2. Agreement to assist with Medical Care. While there is no obligation to incur expenses for providing medical care to a Guest during or after the Activities for causes arising without the fault of the Host, the Host agrees to provide reasonable assistance to any Guest in need of medical care and agrees to reasonably enquire as to any food allergies of any Guest and to inspect all food for ingredients related to any allergies identified by Guest.

3. Financial Responsibility. The Host understands that the Host is solely responsible for expenses the Host may incur in connection with and during the Homestay hosting.

4. Assumption of Risk, Release and Discharge. The Host Family and each of its respective personal representatives knowingly assumes all risks associated with, resulting from, or arising out the Activities participation and fully releases and discharges the City of Southlake and Southlake Sister Cities organization and their respective officers, directors, agents, employees, and representatives (collectively the “**Sponsoring Organizations**”) from any and all liability to any Host Family member while engaging in the Activities. The Host Family further waives any claims against and agrees not to sue any of the Sponsoring Organizations for any and all damages of or injuries to any members of the Host Family while engaging in the Activities, whether or not caused by negligence or carelessness of any of the Sponsoring Organizations.

5. Interpretation and Authority. Texas law shall govern this Agreement and it shall be binding upon the respective heirs, successors, and assigns of each Host Family member. Each member of the Host Family has read and understands the statements made above, and voluntarily sign the Host Family Application. The Host Family acknowledges that no representations, warranties, statements, or agreements, apart from this Host Family Application have been made to any member of the Host Family.
